President's Message

Dear Brothers and Sisters of the Trieste Lodge, First and foremost, I would like to welcome you back from what I hope was a safe and enjoyable summer. I hope that many of you were able to take a break from the hustle and bustle of daily life and spend time relaxing and spending time with family. As Canadians of Italian descent, one of the pillars of our culture is spending time with family - sharing stories and experiences, and of course sharing a

few meals in between. I know that personally I was able to share a few extra meals this summer, but that's what makes life as an Italian one of the greatest in the world.

As we start a new fiscal year at the lodge, I want to inform the membership of the direction that I have given your executive. Over the summer I have thought long and hard about the future of the lodge and what steps must be taken to sustain itself over the long term. One of the key components to the financial success of the lodge is the many events that generate income (Monthly meetings, Spaghetti Supper, Briscola Night, Golf Tournament, Citizen of the Year Gala etc.)

These various events and fundraisers have served us extremely well, and I want to see that continue for many years to come. However, I have come to notice that attendance has stagnated or dwindled over the years, and your executive has reflected on the many reasons for this. The first that comes to mind is demographics - our membership and those that attended traditional events have aged and are no longer able to attend. The other, and what I believe is the main culprit, is changing interests and necessities within our Canadian Italian culture.

There was a time when Italian Canadians were new and recent immigrants to Canada, and their immediate need was to connect with others who shared the same challenges. This served very well as it allowed for many immigrants who came from relative poverty and low income to rise up through the ranks and establish

themselves and their families as successful contributors to Canadian civic life, which is one of the tenets to our membership.

Over time and with every new generation, there is a change in the needs of every organization and its membership. We at the Trieste Lodge find ourselves at a time when those looking to join and become active in the lodge are already long time and committed Canadian citizens, and many are 3rd or even 4th generation Italian Canadians. Their desire to join is not one of necessity, but of one of desire. New members who are joining or are thinking of joining are looking to reconnect with their Italian culture and heritage and ensure that they continue to have a strong connection to their Italian ancestors.

With that in mind, I have directed the executive team to review all events to ensure that they meet these criteria, especially with regards to the promotion of Italian culture and heritage. I have also instructed the executive to share information about our events to other Italian clubs in Hamilton, and in return promote events that other Italian clubs are organizing.

We at the Trieste Lodge are in a unique position relative to other Sons of Italy lodges, as well as other Italian-Canadian clubs in Hamilton. The immense success of our Housing Corporation and Charitable Corporation has put us in an excellent financial position to become the conduit for all those of Italian descent to join together to cherish and support our culture. We are now moving towards the next steps of our visioning session and strategic plan that was initiated by Past President Lou Filice. I am very hopeful that the outcome of this will allow us at the Sons of Italy to expand our reach within the Italian community.

I look forward to serving as your President, and I humbly accept the challenge of ensuring the strength and perseverance of the Trieste Lodge for many years to come.

La Vita E' Bella Radio Show CFMU 93.3 FM




